

## RIGHT TO REMAIN SILENT

The 5th amendment protects our right not to incriminate ourselves.

Also known as the right to remain silent.



You do not have to tell law enforcement where you are from, what your status is or how you entered the US, even if they ask.






## RIGHT TO REMAIN SILENT: IN PRACTICE

## RIGHT AGAINST SEARCHES

# Law enforcement cannot search a person's home or belongings without a warrant signed by a judge.




## SEARCHES: IN PRACTICE

## Do not open your door to law enforcement.

*Tell them to slip the warrant under the door or show through the window.* 

If law enforcement insists on searching you or your property, do not try to stop them.







## Am I free to go?

### I do not consent to a search.





### I am going to remain silent. I want to talk to a lawyer.

### **RED CARDS/ TARJETAS ROJAS**

### **Available in 14 languages. Disponibles en 14 idiomas.** Free printable versions online. Versiones imprimibles gratuitas en línea.

You have constitutional rights:

- DO NOT OPEN THE DOOR if an immigration agent is knocking. If you are inside of your house, show the card through the window or slide it under the door.
- DO NOT ANSWER ANY QUESTIONS from an immigration agent if they try to talk to you. You have the right to remain silent.
- DO NOT SIGN ANYTHING without first speaking to a lawyer. You have the right to speak with a lawyer.
- If you are outside of your house, SHOW THIS CARD TO THE AGENT. Ask the agent if you are free to leave and if they say you can, leave calmly. 4000 m
