5. INFORMATION REPORTS

Report: 5.1 District Audit Report by Wilkinson Hadley King & Co., LLP

Audit Manager Michael Mears spoke and reviewed the audit for the Board. He reviewed what he felt was pertinent information which included Statement of Net Assets, a snap shot of the District, total consolidated funds, the Business Type Activity model (BTA), operation revenues, general fund balance which he stated was at an 8.9% which indicated for the first time an increase in the general fund balance. He reviewed the governmental funds, and clarified the new clarification of fund balance and stated it did not change the amounts just the description.

Report: 5.2 Construction Status Report by Caldwell Flores Winter

Architect Jimmy Sanders spoke and presented a PowerPoint titled *Imperial Community College District, Construction Program Update, January 2012 and* a separate PowerPoint titled *Main Campus Bus Transfer Terminal Improvements dated January 18, 2012.* He reviewed the status of the bus terminal project, 400 building, and the Career Technology Building.  - Reported that the Stop Light Project went well. He stated that Imperial County Public Works Director William Brunet sent him an email stating that the two separate local agencies worked well together for the common good of the taxpayer.
