**If an ICC rep misses 2 consecutive ICC meetings or 3 total meetings in a semester, then CSEA, Academic Senate, Confidential, ASG, or the President/Superintendent will be asked to provide a replacement member from the same standing committee.**

\*The total representatives from faculty, classified, confidential, student, and administration must stay constant even if the committee for which they serve as co-chair may fluctuate.

\*\*Two faculty representatives will be nominated by the committee since the person selected will serve as the committee co-chair, but Academic Senate will affirm this co-chair to serve as a faculty rep for ICC. If neither of the nominations are affirmed, then Academic Senate may designate another faculty from the same standing committee to serve as the ICC rep.

Two classified representatives will be nominated by the committee since the person selected will serve as the committee co-chair, but CSEA will affirm this co-chair to serve as a classified rep for ICC. If neither of the nominations are affirmed, then CSEA may designate another classified from the same standing committee to serve as the ICC rep.

Two confidential representatives will be nominated by the committee since the person selected will serve as the committee co-chair, but the confidential group will affirm this co-chair to serve as a confidential rep for ICC. If neither of the nominations are affirmed, then confidential group may designate another confidential from the same standing committee to serve as the ICC rep.

^The President/Superintendent will affirm the committee co-chair will serve as an administrative rep for ICC.

The ASG will affirm the student representatives who will serve on ICC.

+ At large members will be affirmed by the Academic Senate, the CSEA, the Confidential Group, the ASG, or the President/Superintendent respectively.
